

## **FINLAY SCREENING & CRUSHING SYSTEMS PTY LTD ACN 059 443 677 COLLECTION STATEMENT (INCLUDING CREDIT INFORMATION)**

Finlay Screening & Crushing Systems Pty Ltd (ACN 059 443 677) and its related bodies corporate (as defined in the Corporations Act 2001 (Cth)) are committed to protecting the privacy of your personal information. The primary purpose we collect personal information from you is to provide you with our services and specialist crushing, screening and processing equipment for the mining, quarrying and waste recycling industries in Australia. The primary purpose may also include assessing your suitability for employment. We may also use or disclose the personal information for secondary purposes that are within your reasonable expectations and that are related to the primary purpose of collection such as to inform you of relevant updates and changes in the equipment or the industry that may affect you or your business, for warranty, product improvement and customer support purposes, to enable our supplier Terex Corporation to register a customer profile and to enable the customer's fleet management system, and to use the information gained from telematics to capture machine data, warranty and spare part issues and related information and to invite you to events.

Our usual process of collecting personal information is to collect the personal information directly from you. We may also collect personal information from other sources, such as suppliers or creditors, or from banks or other credit providers. We will only collect the personal information from these other sources if it is necessary to provide you with our services or assess your suitability for employment, or you have instructed us to collect your personal information from those sources.

If you do not provide us with your personal information, we may not be able to complete your order, or provide you with our services, or consider your suitability for employment.

Your personal information may be disclosed to other entities such as other service providers (including freight and transport), referral partners, our debtor financiers, government bodies, and the manufacturers of the equipment we supply to you such as Terex Corporation.

When you buy or your business buys goods from us which have telematics in them, we will disclose your name and email address to Terex Corporation, which is based in and has servers located in the United States of America. Otherwise, we do not generally disclose your personal information to overseas recipients.

Where we disclose your personal information to entities overseas such as Terex Corporation, we take reasonable steps to ensure that those parties will handle the personal information in accordance with the Australian Privacy Principles. We are not required to take such steps if we believe that the overseas recipient is already subject to a law that has the effect of protecting personal information in a substantially similar way to the relevant law in Australia, or with your consent.

We may also check your credit information with a credit reporting body. The credit reporting bodies we use include Equifax Pty Ltd (formerly Veda) and Dun & Bradstreet and you can contact them through their website at <https://www.equifax.com.au/> and <http://dnb.com.au/> or contact us for further information.

We do not provide your information to credit agencies.

You can request that the credit reporting body not use your information for the purposes of pre-screening for direct marketing by another credit provider. You can also request the credit reporting body not use or disclose credit reporting information about you, if you believe on reasonable grounds that you have been, or are likely to be, a victim of fraud.
